To carry out the objectives of the Instrumental Music Activity Program and to follow the policies and procedures of Campbell County School District.

JOB FUNCTIONS:**ESSENTIAL FUNCTIONS:**

1. Supervise the Instrumental Music Activity Program at assigned school under the direction of the Building Principal.
2. Supervise all performances and practice sessions.
3. Prepare students for all performances and approved regional and state events.
4. Coordinate clinics and regional events that are held at assigned buildings.
5. Have a thorough understanding of the rules and regulations regarding the Instrumental Music Activity Program.
6. Keep an accurate and up-to-date inventory.
7. Assume responsibility for the constant care of equipment and facilities used for the program.
8. Inform students of awards criteria at the beginning of the year and recommend students for awards based on a fair interpretation of that criteria.
9. Recommend budget items for the activity portion of the Instrumental Music program to be included in the building instrumental music budget.
10. Recommend facility maintenance or improvements.
11. Communicate regularly with supervisors regarding the progress and development of the Instrumental Music Activity Program.
12. Prepare a detailed annual report highlighting the activity accomplishment, participation levels and recommendations for improvement of the activity.
13. Perform other duties or tasks related to the Instrumental Music Activity Program including, but not limited to, offering private lessons at no charge, jazz bands, pep bands, seasonal bands, seasonal groups and other groups of student interest that are not included in the curriculum.
14. May be responsible for supervising students on out-of-town activities. This may involve staying

overnight.
